#### **FULL DAY - IBC Updates Significant Changes**

Based on legislative updates in 2018, 2021, and 2024, the International Building Code (IBC) has incorporated significant changes affecting building safety, energy efficiency, and material applications. This course provides participants with a detailed review of updates, practical guidance for compliance, and strategies for applying the revised code in modern construction projects

# FULL DAY – Permitting and Planning Professional Development & Certifications Two Part Class

ADVANCED ROLES IN PERMMITING AND PLANNING - (AM)

This advanced course is designed for permit technicians, plan examiners, and city clerks. Participants will explore ICC certification pathways, zoning fundamentals, and compliance procedures. Attendees will gain a stronger understanding of how permitting, planning, and inspections intersect.

#### GUIDED AI PLAN REVIEW AND ETHICAL AI PRACTICES (PM)

This course introduces participants to the use of guided AI tools in plan review, focusing on how AI can improve review efficiency while maintaining ethical standards. Participants will explore the impact of AI on reducing permit backlogs and achieving faster approvals.

#### FULL DAY - 2021 Townhomes & Alternative Dwelling Structures

Training is designed for building officials, inspectors, plans examiners, and design professionals in Idaho who are working with innovative housing forms under the 2021 International Residential Code (IRC). The class will focus on the unique code provisions, appendices, and IBC references that directly affect residential construction in Idaho. Topics covered will include: Townhomes, Tiny Homes, ADUs, Strawbale Construction, Intermodal Shipping Containers. The class will address key provisions, fire resistance, separation requirements, best practices and structural considerations.

#### HALF DAY (AM)- IBC Fire-rated Construction and Proper Use of Materials

This course covers fire-resistant rated construction per the 2024 International Building Code (IBC). You will learn what fire-resistance is, as well as how to differentiate that type of fire performance from other types including flame propagation and combustibility. We will then explore what the IBC requires and how to apply those requirements correctly. We will also understand common materials in construction, when they are permitted or prohibited, and what role they play in the fire performance of the building.

#### HALF DAY (PM)- Gypsum Association Resources for Code and Construction Professionals

Course equips code enforcement officials and construction professionals with essential technical knowledge about gypsum panels, their proper installation, and their critical role in meeting standard requirements—particularly in areas of fire resistance and sound control. Participants will gain practical skills in using key code-referenced publications GA-600 and GA-216, to verify compliance with building standards. The course also includes an overview of free publications available through the Gypsum Association Bookstore, covering topics such as repair, weather-related considerations, and best practices for handling and transporting gypsum panels.

#### FULL DAY - Single Family Homes - from Application to Occupancy

Planning and permitting to final inspection, the construction of single-family detached homes demands a level coordination and technical precision at every phase. This course provides participants with an in-depth understanding of critical inspection processes, regulatory compliance considerations, and the complex integration of structural, mechanical, and administrative components essential to achieving successful projects.

#### FULL DAY IEBC - Continued Use & Reuse of Existing Buildings

Addresses the relationship of the IEBC to existing buildings. Focuses on the fundamental requirements of IEBC that are placed on an existing structure that undergoes repair work, alteration, renovation activity or construction of an addition, and the effect of a change in the building's occupancy classification. Briefly discusses the "compliance alternatives" method. Topics include regulations of additions, alterations and repairs, changes of occupancy considerations, compliance alternatives and application of the IEBC

#### FULL DAY - IBC - Structural Plan Review

This seminar equips participants to perform structural plan reviews per the 2018 IBC®. Attendees will evaluate construction documents, verify compliance with gravity and lateral load requirements, assess foundations, structural components, and materials, and identify site-specific hazards. Emphasis is on ensuring complete, continuous load paths and proper structural detailing, enabling participants to confidently conduct simplified structural plan reviews and understand their critical role in the building process.

#### HALF DAY AM- Manufactured Housing Inspection and Installation

This Idaho-approved, four-hour course is designed for inspectors and installers Based on HUD standards, participants will learn to inspect key systems—including structure, plumbing, HVAC, electrical, and foundations—evaluate accessory buildings, and communicate defects. The course also covers installation procedures, permitting, and Idaho licensing requirements (IDAPA 07.03.11), providing practical, HUD-approved training to support certification and continuing education.

# HALF DAY (PM)- Floodplain Regulations for Manufactured Homes & Accessory Structures; Elevation Certificates & Methods for changing a Flood Map

This course addresses NFIP requirements for manufactured homes and accessory structures in floodplains, including detached garages, sheds, and agricultural buildings. Participants will learn floodplain permit compliance, use of Elevation Certificates, and methods for updating or correcting FEMA NFIP maps through various revisions and amendments. IDWR floodplain management staff provide guidance to local officials to ensure proper implementation and adherence to regulatory standards.

HALF DAY (AM) - Residential Roofing Inspection and Code Compliance

This course provides inspectors and code professionals with a detailed understanding of residential roofing systems, including asphalt, tile, clay, and wood shingles. Instruction covers evaluation of modifications, additions, and storm-related damage while applying manufacturer specifications and code requirements. Emphasis is placed on inspection procedures, documentation standards, and maintaining objectivity to ensure structurally sound, compliant roof installations under varying field conditions.

This course provides a detailed overview of key updates from ASCE 7-16 to ASCE 7-22,

addressing revisions to rain, flood, wind, seismic, and snow load provisions. Participants will examine reliability-targeted ground snow loads, their implications for Idaho, and the

application of the ASCE Hazard Tool. The session concludes with a preview of ASCE 7-28

FULL DAY - Firestop 101: Inspection and Compliance

This course provides advanced training for inspectors, architects, and AHJs on evaluating firestop and anchoring systems for accuracy and compliance. Participants will review firestop principles, system selection, inspection procedures, and specification requirements for chemical anchors. Emphasis is placed on current codes, testing standards, and real-world applications to improve identification of installation deficiencies and ensure safe, code-compliant fire-rated assemblies

FULL DAY - Building Fundamentals and Planning (Two Part Class)

2024 IBC Types of Construction (AM) - Based on IBC Ch. 6 - Identification of the construction materials and fire-resistance-rated features associated with the varied individual construction types. The permissible use of combustible materials in Type I and II noncombustible buildings will also be addressed

2024 IBC Mixed Occupancies (PM) - Based on the provisions of IBC Section 508 - Special requirements applicable to buildings containing two or more occupancy classifications. Three mixed-occupancy options are presented. Included: occupancy classification, mixed occupancy conditions, accessory occupancies, nonseparated occupancies, separated occupancies and multistory conditions.

This full-day course prepares residential inspectors for commercial inspections, covering essential preparation, tools, and inspector-contractor interactions. Primary focus is on technical inspection methods; foundations, wood and light-gauge steel framing, fireresistive construction, means of egress, and accessibility requirements. Knowledge and skills to evaluate commercial structures with precision and code compliance.

Participants will review construction practices, fire sprinkler coordination, and case studies to enhance understanding of performance, efficiency, and regulatory requirements for safe, cost-effective podium projects.
